

Membership

Qualification, Application and Admission

- 9.1 Any natural person, who is a Chief Executive Officer of any Public Enterprise, shall be a Member of the Forum.
- 9.2 Any natural person, who is an Acting Chief Executive Officer of any Public Enterprise, shall be a member of the Forum.
- 9.3 Any natural person who is recommended, in writing, by any Chief Executive Officer of any Public Enterprise, shall register for associate membership of the Forum. Any person registered under this 9.3 may attend meetings but shall not be eligible to vote.
- 9.4 Registrations for Membership are made by: -
 - 9.4.1 Completing a prescribed registration form; and
 - 9.4.2 Paying a non- refundable membership fee as determined by the Annual General Meeting (AGM) from time to time.
- 9.5 The Forum Executive Committee may accept or reject registration for Membership in its discretion.

Categories of Membership

- 9.6 There shall be two categories of Membership, being ordinary Membership and Associate Membership.

Loss and Reinstatement of Membership

- 9.7 Membership of the Forum shall be lost:-
 - 9.7.1 When a member terminates his/her membership from the Forum or when the member for whatever reasons no longer serves as Chief Executive Officers of the Public Enterprise, or when a member no longer qualifies for membership under 9.1., 9.3 of this Constitution;
 - 9.7.2 When yearly subscription of a member remains unpaid for one year after it falling due;
 - 9.7.3 Upon a two thirds majority resolution of the Forum in a General Meeting; and
 - 9.7.4 Upon the Public Enterprise for which such CEO was appointed being deregistered.

Reinstatement

- 9.7.5 Subject to these Articles, and subjects to payment of any outstanding subscriptions, the Executive Committee may reinstate a former Member who

lost Membership under Article 9.7 on such terms and conditions as it may determine.

Rights and Privileges of Membership

- 9.8 The Forum is an incorporated as a Forum not for gain.
- 9.9 Accordingly: -
 - 9.9.1 The members have no rights in the assets of the Forum;

And
 - 9.9.2. The Forum shall apply its income and profits only for the purposes of promoting its Objects and shall pay no dividends to its Members.
- 9.10. The Principal rights and privileges of Members shall be those set out in this Constitution.
- 9.11. Subject to the provisions of Articles 9.9 and 9.10, the Forum may create, vary and abolish further rights and privileges of Members.
- 9.12. Members' rights or privileges are not transferable
- 9.13. Rights and privileges of third persons are lost upon loss of membership of the member from whom these rights and privileges are derived.

Obligations and Duties of Membership

- 9.14 Every member shall pay the early subscription fee.
- 9.15. The yearly subscription fee shall become due on the commencement of the financial year of the Forum.
- 9.16. The Forum shall determine the amount of the yearly subscription fee (if any) at the Annual General Meeting from time to time.
