### **PUBLIC ENTERPRISES ANNUAL AWARDS**

The PE CEOs' Forum is pleased to announce the Public Enterprises Annual Awards. The Forum resolved to establish the annual awards, in recognition of those Public Enterprises who perform at their peak and strive towards Corporate Governance and compliance to PEGA. The awards were launched on 03 June 2021 by the Right Honourable Prime Minister, Dr. Saara Kuugongelwa-Amadhila.

These awards will honour Public Enterprises, whose performance has demonstrated their commitment towards furthering their stakeholders' expectations over the previous year.

The awards will be adjudicated by an independent Committee annually and conferred to deserving individuals and institutions in the following categories:

#### 1. BEST PERFORMING PUBLIC ENTERPRISE

This award will consider the Quarterly Performance Report, achievement of KPI's, both financial and non-financial, Going Concern consideration as well as the Annual Report at the end of the Financial Year. Organizations with an Integrated Report would have an added advantage.

#### 2. CHIEF EXECUTIVE OFFICER "CEO" OF THE YEAR

This award will look at the CEO's vote by peers, performance of the company, employee engagement survey, publicity, CEO's engagement with stakeholders, media presence, and stakeholder satisfaction.

#### 3. CORPORATE SOCIAL RESPONSIBILITY

This category considers Corporate Social Responsibility initiatives.

#### 4. GOVERNANCE & COMPLIANCE

This category considers the Public Enterprise Governance Act and compliance with the NAMCODE.

## 5. PUBLIC ENTERPRISE WITH THE BEST PUBLIC IMAGE (Brand Identity)

This category will look at media coverage and brand image.





#### 6. MOST IMPROVED PUBLIC ENTERPRISE

This award considers the achievement of KPI's, both financial and non-financial, as well as the brand image of the particular Public Enterprise.

Public Enterprises are hereby requested to nominate themselves for any of the abovementioned categories, and provide the necessary portfolio of evidence for consideration.

The Public Enterprises Chief Executive Officers' Forum was incorporated as a Non-profit Association, under Section 21 of the Companies Act 2004, on 09 February 2017.

The Forum creates an opportunity for Public Enterprises to give input on matters relating to legislation, policies, and other directives. It also provides a platform for exchange of ideas on key matters affecting Public Enterprises, such as governance, strategy, and operations.
